I (We) will not sell, transfer, export or re-export any parts purchased from Tradewind International, LLC, for use in activities which involve the development, production, use, or stockpiling of nuclear, chemical or biological weapons or missiles, nor use parts purchased from Tradewind International, LLC, in a facility engaged in activities related to such weapons.
3. I (We) acknowledge that the US Government prohibits the sale, transfer, export or re-export or other participation in any export transaction parts purchased from Tradewind International, LLC, with individuals or companies listed in the **Consolidated Screening List** or in the following individual US Government lists: US Department of Commerce **Denied Persons List, Unverified List, or Entities List**, or the US Department of the Treasury **Specially Designated Nationals List**, or the US Department of State **List of Statutorily Debarred Parties**.
